**Minutes of St. Ive Parish Council Annual Meeting held at

**1. Chairman's report**

Cllr McWilliam said the last year had been challenging and with some ongoing difficulties. The highlights had been Cllr Carters success in getting the youth project started, the fundraising efforts of the Pensilva Park Project. The Celebrate Success evening in December had been very well attended and brought community groups together.
