143. PUBLIC PARTICIPATION

Cllr Bennison advised he had been asked to speak on behalf of Mr A Collins, to be dealt with under Finance.

Cllr Dipper advised that the Council are divided over Mr Wadge's co-option. There is a need for more Councillors but a conflict of interest with the Victoria and the Mel bars. Mr Wadge was asked what he feels he can bring to the Council.

Accounting procedures were discussed at length with the Finance Clerk in view of the queries raised by Mr Collins, it was agreed to stay with existing procedures to progress the year end accounts but to discuss in more detail at the Finance and Administration meeting on 22nd April 2014.

Cllr Dipper reported issues with the EPOS till system since the computer was relocated to the General Managers office, the Ethernet connection has not been working, the computer has defaulted to the wireless network. However as this is not consistent it has resulted in several days of sales being downloaded from the till as one day. A procedures manual is required for the Epos till system.

Cllr Neal asked if the external stock check of the bar had taken place, the Clerk confirmed that it had.

young people. Cllr Carter asked if the Parish Council would pay doe CRB checks, if for a Charity cost £17, other wise £35 per person.
