The Chairman declared the meeting open at 7.30pm and welcomed the members of the public.

25. APOLOGIES – Cllrs P Carter and S McWilliam.

26. PUBLIC PARTICIPATION

Request from Pensilva football Club for a 3 foot by 2 foot sign on the lawn at the front of Millennium House, "V" shape to be viewed form both directions. Also a request for advertising boards around the pitch fencing.

After discussion at length it was agreed to discuss further and agree detail at a Parks and Open Spaces meeting to be held on 21st July 2014 at 7.30pm at Millennium House.

30. PLANNING APPLICATIONS

30.1 Applications Received Prior to Issue of Agenda

PA14/05209 Construction of new dwelling including: Demolition

Mr M Briggs

of existing garage to Couchs Lodge, new vehicle and pedestrian access, 2 parking spaces and turning area, external landscaping, new boundary fencing and walls (outline application with all matters reserved).

A resident from Princess Road expressed concerns over the application. Cllr Dipper proposed refusal of the application, seconded by Cllr Bennison, unanimous decision.

Grounds for refusal being the highways issue of cars parked on both sides of the road and the issue of safety when exiting driveways.

In addition the long garden is a historical component of the World Heritage Site and it has been recommended that this is an asset to be preserved.

PA14/05664 Stationing of container for storage of maintenance equipment and spare parts for use in association with existing solar farm permitted under PA12/0666, together with erection of 2m high Palladin Security fencing

After discussion it was agreed that the Clerk should seek clarification for the fencing, is it solely for the area outlined in red on the application or for the whole of the solar panel site and an extension until 25th July when it may be discussed at the planning meeting to be held on 22nd July.

PA14/05641 Retention of pole barn – Land Pts Os 4255 4967 Louis adjoining Scrawsdon Farm, Golberdon Hudson

After discussion Cllr Corney proposed oppose the application as it is obtrusive on the landscape as there is no screening, seconded by Cllr Mutton. Five votes in support of opposing the application and three abstentions.

30.2 Applications Received After Issue of Agenda – none received

31. AUTHORISATION OF PAYMENTS JUNE 2014

Cllr Kendrick-Crawshaw proposed the payroll £6,883.92 be ratified, seconded by Cllr Bennison, unanimous agreement.

Cllr Bennison proposed the creditors £8,179.55 be paid, seconded by Cllr Moss, unanimous decision.

Debtors of £6,323.11 noted. The Finance Clerk is chasing the aged debtors.

32. BUSINESS

32.1 Francis Clark independent review – Cllr Bennison remarked that the report has given confidence in the accuracy of data. By commissioning the report we have shown a duty of care to the Community.

Cllr Neal questioned the VAT claim on the pay equipment and requested this item be added to the Agenda for the Finance and Administration meeting.

Cllr Dipper is meeting with the Pensilva Play Park project on 17th July to clarify their application for funding for fencing.

33. CORRESPONDENCE

33.1 Butchers Arms – Should it be listed as an Asset of Community Value? After discussion it was agreed unanimously not to list as an Asset of Community Value as this would halt the sale for six months which could be detrimental to the fabric of the building following the collapse of the chimney. As the building is grade11 listed any application for change of use would be advised to the Parish Council.

34. REPORTS AND RECOMMENDATIONS FROM COMMITTEES

- 34.1. Finance and Administration Committee
 - Grant for St Ive District Church £400 towards upkeep of Cemetery proposed by Cllr Kendrick-Crawshaw, seconded by Cllr Moss, unanimous decision. Grant for St Ive Methodist Church £400 towards upkeep of Cemetery proposed by Cllr Wadge, seconded by Cllr Bennison, seven votes in agreement (Cllr Mutton abstained as he had declared an interest).
- 34.2 Neighbourhood Development Plan Cllr Corney advised the survey has been issued and we are now in the six week period waiting for responses. St Cler have 18 people on their committee and they are making more rapid progress. Cllr Neal asked if this is a cost to the Community. Cllr Corney responded that it is being funded by Locality.
 - 34.3. Community Network Area Meetings LHYSP, item detailing scam to be published in the Parish Pump. **Action: Clerk to advise the editor.** Cllr Dipper advised Cormac have a trailer which can be booked by volunteer groups for clearance works, if their risk assessment is completed we would be covered by Cormac's insurance. It has been booked for Gala Day as a display for interested groups.
- 34.4 St Ive Village Hall thriving
- 34.5 Youth Projects Cllr Corney reported that the Friday Club is infringing on the availability of the Sports Hall for the dance session which may need to move to a different evening.
- 34.6 Gala week committee Cllr Dipper reported that since this was set up it had only met once. Keira Rendle has recently stepped down as the Chair; Katrina Williams has stepped in and had a meeting with Millennium House Manager and Cllr Dipper. More Arena events are required. The Manager is drafting the programme for the centre page of the Parish Pump.

Volunteers will be required for the Gala Day.
