**Minutes of St. Ive Parish Council meeting held at  
St Ive Village Hall, St. Ive on Monday 12<sup>th</sup> January 2015 at 7.30pm**

The Chairman declared the meeting open at 7:35pm and welcomed the members of the public.

**100. APOLOGIES** - Cllrs P Carter, L Olver, H Frith and C Wadge

County Councillor Mrs S McWilliam is on long-term sick leave from her role as Cornwall Councillor. Cllr Dipper read to the council and members of the public Cllr J Kendrick-Crawshaw's resignation letter.

**101. PUBLIC PARTICIPATION –**

Mrs Bunkum thanked Cllr Dipper for attending the Planning Committee meeting held at Luxstowe House. Cllr Dipper raised the objections of the parishioners in relating to application PA14/08999 - Land rear of Methodist Chapel, Chapel Lane, St. Ive – Construction of local needs dwelling to include provision of septic tank.

Mr Bennison informed council that it was rumoured that a substantial rise in the precept for the coming year was being considered by the parish council. Mr Bennison requested that council consider the affect any rise in council tax would have on parishioners.

#### **107.2 St. Ive Community Park Project – Solar Farm monies**

Cllr Corney wished to confirm that monies received from the solar farm fund and raised at various functions held by the St. Ive Community Park Project committee were ring fenced and allocated a separate nominal code within the parish council accounts. Cllr Dipper was of the opinion that these safeguards were already in place.

#### **107.3 Devolution and Decentralisation – Case for Cornwall**

Notification of a meeting being held on the 11<sup>th</sup> February 2015 at Kinsley Village, Fraddon by the Cornwall for Change group was read to council. It was agreed to maintain a watching brief.

#### **107.4 Bus Shelters**

Further funding avenues had been explored and discussed. Mr Bennison informed members that a bus shelter was needed in Pensilva for the school children and this had been agreed by parish council in recent years. Cllr Corney suggested that possibly a community group could approach Viridor for funding as parish councils are unable to.
