## St Ive Parish Council



### **Minutes of the Meeting of the St Ive Parish Council held at 7.30pm on the 9<sup>th</sup> November 2015 at St Ive Village Hall.**

**Present:** Cllrs: Corney, Haimes, Neal, Moss, Carter, Dipper and Waddington.

**223. Apologies:** None.

**224. Public Participation:**

#### **224.1 Public Participation – Questions**

Member of the public brought to Councils attention a previous Planning Application that had been refused twice applications PA15/03376 and PA14/10579. Council had been neutral on the application discussed previously, Cllr Corney reported that unless a new application was submitted that Council were not technically qualified to support this appeal and their previous decision would still stand.

**224.2** Member of the Public raised the question of: Who the official photographer advertising free photographs at Millennium House? Council reported that the photographer was not a member of Parish Council.

**224.3** Roger Bennison requested that his application to be co-opted onto Council be discussed and Chair responded that currently St Ive Parish Council has two vacancies for the ward of St Ive, and as the application was received after the Agenda was set that the procedure would be adhered to and although Roger Bennison would be able to introduce himself to Council the Council would not be voting on this matter at this meeting. A Councillor raised his concerns over the co-option and reported that he may be forced to reconsider his position.

#### **226. Previous Minutes**
