95. Election of Chairperson;

Cllr Neal Proposed Cllr Bennison takes over as FAC Chair, Seconded Cllr Waddington – Unanimously Agreed.

96.Councillors Declarations of Interest: Cllr Haimes Matters relating to Millennium House Café .Cllr. Corney Matters relating to St Ive Park Project.

97. To receive questions or statements from members of the public:

Pensilva Football Club representatives and Committee discussed the £50 per month requested as a payment from the club for the use of Pitch, contribution to Grass Cutting costs and Committee suggested that the Football Club take responsibility for the Grass Cutting. The Football Club provided detailed accounts for the Committee to reconsider the charge of £50 per month. The Football Club and Parish Council Cllr Corney proposed should arrange a meeting to discuss this further.

If the Football Club were to use they would have to have adequate Insurance. Cllr Haimes Proposed that at the next Parish Council Meeting we go ahead with the purchase of the lawn Mower. Cllr Corney to investigate the storage options at MH.
